

RESOLUTION NO. 2009-4

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ANNETTA NORTH, TEXAS, CALLING FOR A GENERAL ELECTION TO BE HELD ON MAY 9, 2009, ESTABLISHING PROCEDURES FOR THAT ELECTION, AUTHORIZING A NEW METHOD OF VOTING; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Annetta North, Texas is a Type B general-law municipality located in Parker County, created in accordance with the provisions of Chapter 7 of the Local Government Code and operating pursuant to the enabling legislation of the State of Texas; and

WHEREAS, May 9, 2009 is designated as a uniform Election Day at Which time the votes will elect persons to fill the offices of Mayor and Councilmember's Place 3 and 4; and

WHEREAS, by this Resolution, it is the intention of the City Council to call the general election, designate a polling place for the election, to appoint the necessary election officers and to establish and set forth procedures for conducting the election.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ANNETTA NORTH, TEXAS, THAT:

Section 1.

Election Order. A general election shall be held in the City of Annetta North, Texas, on Saturday, May 9, 2009 at which the following officials will be elected for two year terms commencing May, 2009 until May, 2011 or until a successor is duly qualified:

Section 2.

Polling place. The polling place for the General Election shall be as follows:

Annetta Methodist Church  
Fellowship Hall  
2836 FM 5  
Annetta, Texas 76008.

The polls shall be open from 7:00 a.m. until to 7:00 p.m. on May 9, 2009, in accordance with and pursuant to the requirements of the Texas Election Code (the "Code").

The City shall constitute a single election precinct for said election.

Section 3.

Application for Place on Ballot. In accordance with the Code, eligible persons wishing to become candidates must file application with the City Secretary of the City of Annetta North, P.O. Box 1238, Aledo, Texas 76008, and may do so beginning at 8:00 a.m., February 7, 2009, and continue through March 9, 2009, until 5:00 p.m. The order in which the names of the candidates are to be printed on the ballot will be determined by a drawing by the City Secretary in the manner on a form prescribed by the Code.

Section 4.

Early Voting.

(a) Early Voting by Personal Appearance. The City Secretary, City of Annetta North, P.O. Box 1238, Aledo, Texas 76008 is hereby designated as the Early Voting Clerk and she may appoint the necessary deputy clerks as required for early voting. Early voting by personal appearance shall be conducted between the hours of 8:00 a.m. and 5:00 p.m. Monday through Friday, on each day that is not a Saturday, Sunday or state holiday beginning on Monday April 27, 2009 and continuing through Tuesday May 5, 2009, except that on April 29, 2009 and May 4, 2009, early voting hours shall be expanded to 7a.m. thru 7p.m. Early Voting by personal appearance shall be at the home of Jim and Patsy Perkins, 435 Quail Ridge, Annetta North, Texas 76008.

(b) Early Voting by Mail. Applications for early voting by mail shall be mailed to City Secretary, City of Annetta North, P.O. Box 1238, Aledo, Texas 76008, not earlier than Tuesday, March 10, 2009, and not later than the close of business on Friday May 1, 2009, if delivered by mail, or Tuesday, May 5, 2009, if delivered in person.

(c) Early Voting Ballot Board. Early voting shall be canvassed by the Early Voting Ballot Board, which is hereby created. The Presiding Election Judge and the Alternate Presiding Judge appointed herein shall serve as the presiding officer and the alternate presiding officer, respectively, of the Early Voting Ballot Board. The other election officers serving at the election shall serve as the other members of the Early Voting Ballot Board for the election.

Section 5.

Appointment of Election Judge and Alternate Election Judge. The following named individuals are hereby appointed to serve as presiding Election Judge and Alternate Presiding Judge, respectively, at the election:

The Presiding Election Judge and Alternate Presiding Judge shall be qualified voters of the City. The City Secretary shall, in accordance with Section 32.009 of the Election Code, deliver to the Presiding Election Judge and the Alternate Presiding Judge notice of their appointments not later than twenty (20) days from the effective date of this Resolution.

Section 6.

Appointment of Clerks. The Presiding Election Judge for the polling place shall appoint Election Clerks and as many additional Clerks as are necessary for the proper conduct of the election. Provided, however, three (3) clerks shall be the maximum number of Clerks which may be appointed to serve at the polling places. The Judge shall make a reasonable effort to appoint at least one (1) bilingual election clerk.

Section 7.

Governing Law and Qualified Voters. The election shall be held in accordance with the Constitution of the State of Texas and the Election Code, and all resident qualified voters of the City shall be eligible to vote at the election.

Section 8.

Publication and Posting of Notice of Election. Notice of the election shall be given as required by Chapter 4 of the Election Code.

Section 9.

Submission to the United States Justice Department. The City Secretary of the City of Annetta North, Texas, or her designee, is authorized to make such submission to the United States Justice Department to seek pre-clearance as required by law.

Section 10.

**Delivery of Returns. In accordance with the Election Code, immediately after the closing of the polls on the day of the election, the election officers names in this resolution shall make and deliver the returns of the election in triplicate as follows: one copy shall be retained by the Presiding Election Judge; one copy shall be delivered to the Mayor of the City; and one copy of the returns, together with the ballot boxes and all election supplies, shall be delivered to the City Secretary. All election records and supplies shall be preserved by the City Secretary in accordance with the Election Code.**

Section 11.

**Effective Date. This resolution shall be effective upon its adoption.**
