

ORDINANCE NO. 2025-02

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF ANNETTA NORTH, TEXAS, CANCELLING THE MAY 03, 2025 GENERAL ELECTION AND DECLARING EACH UNOPPOSED CANDIDATE ELECTED TO OFFICE; PROVIDING THAT THIS ORDINANCE SHALL BE CUMULATIVE OF ALL ORDINANCES; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the Town of Annetta North, Texas is a Type A general-law municipality located in Parker County, created in accordance with the provisions of Chapter 7 of the Local Government Code and operating pursuant to the enabling legislation of the State of Texas; and

WHEREAS, in accordance with law a general election has been ordered for May 03 2025 for the purpose of electing three Council Members, to serve on the Board of Council of the Town of Annetta North; and

WHEREAS, no proposition is to appear on the ballot; and

WHEREAS, the Town Secretary has certified in writing that each candidate on the ballot is unopposed for election to office; and

WHEREAS, the filing deadlines for placement on the ballot and declaration of write-in candidacy has passed; and

WHEREAS, in these circumstances Subchapter C of Chapter 2 of the Election Code authorizes a governing body to declare each unopposed candidate elected to office and to cancel the election.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMAN OF THE TOWN OF ANNETTA NORTH, TEXAS, THAT:

Section 1.

The following candidates, who are unopposed in the May 06, 2023 general election are hereby declared elected to office, and shall be issued a certificate of election:

**MAYOR-ROBERT SCHMIDT
COUNCIL PLACE 3-JAMES S HAMILTON
COUNCIL PLACE 5-KIRK JOSEPH**

Section 2.

The May 03, 2025 General election is hereby cancelled.

Section 3.

Each candidate elected so named in Section 1 of this Ordinance shall be administered the oath of office at the regular meeting place for the Town of Annetta North and may exercise the duties of office at the first council meeting occurring after May 03, 2025.

Section 4.

The City Secretary is directed to post a copy of the order of cancellation at each designated polling place on May 03, 2025.

Section 5.

This ordinance shall be cumulative of all provisions of ordinances of the Town of Annetta North, Texas, except where the provisions of this ordinance are in direct conflict with the provisions of such ordinances, in which event the conflicting provisions of such ordinances are hereby repealed.

Section 6.

It is hereby declared to be the intention of the Board of Council that the phrases, clauses, sentences, paragraphs, and sections of this ordinance are severable, and if any phrase, clause sentence, paragraph or section of this ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this ordinance, since the same would have been enacted by the Board of Council without the incorporation in this ordinance of any such unconstitutional phrase, clause, sentence, paragraph or section.

Section 7.


This ordinance shall be in full force and effect from and after its passage and it is so ordained.
