TOWN OF ANNETTA NORTH TOWN COUNCIL REGULAR MEETING MINUTES FEBRUARY 14, 2023

The Town Council held its Regular Meeting at 7:00 p.m. on Tuesday the 14th of February 2023 at the Annetta Methodist Church, Annetta, Texas

Mayor Robert Schmidt, Mayor Pro-Tem Rob Watson, Councilmembers, Ryan McConnell, Stonie Hamilton, Kirk Joseph and Dr. John Johnson were present and constituted a quorum. Also present was Town Attorney Lindsey Hale.

Call to order

The meeting was called to order at 7:00 p.m.

Citizens' remarks on items of interest

There were no Citizens' remarks on items of Interest.

Old Business

 Discussion and possible action regarding the SevenFold Farm Conservation Easement annual inspection report and grazing plan and accepting an additional conservation easement in the SevenFold Farm Addition which is adjacent to the existing SevenFold Farm Conservation Easement held by the Town of Annetta North.

Councilmember Hamilton made a motion to approve the SevenFold Farm Conservation Easement annual inspection report and grazing plan. Councilmember Johnson seconded the motion. The motion carried 4 for-Joseph, Hamilton, Johnson, & McConnell, 0 against, 1 abstain-Mayor Pro-Tem Watson.

2. Discussion and possible action regarding the roads and bridges in the Town of Annetta North

Mayor Schmidt briefed the Town Council regarding the status of the roads. There was no action taken on this item.

3. Update/discussion and possible action regarding the assignment of fee to internet providers for use of telephone poles in the Town of Annetta North (Councilmember Hamilton to provide update)

Former Mayor Ken Hall addressed the Town Council and suggested a possible ordinance that regulates the usage of well water when filling stock tanks in the Town of Annetta North. There was no action taken on this item.

After extensive discussion the Town Council members felt that this issue had recently been addressed by the digging ordinance approved in December 2022. There was no additional action taken on this item.

5. Discussion and possible action regarding waiver of conflict of interest for Baird Hampton & Brown to provide engineering services for a parcel owner at 4517 Annetta CenterPoint Road in the Town of Annetta North

Mayor Pro-Tem Watson made a motion approving a waiver of conflict of interest for Baird Hampton & Brown to provide engineering services for a parcel owner at 4517 Annetta CenterPoint Road in the Town of Annetta North. Councilmember Joseph seconded the motion. The motion carried 5-0.

6. Discussion and possible action regarding preliminary/final platting of Lots 1 & 2, Block A, Buck Dobbs Addition, a subdivision in Parker County, Texas, and originally being a 27.39-acre tract of land situated out of the Andrew J. Bell Survey, Abstract No. 129, Parker County, Texas

Mayor Pro-Tem Watson made a motion approving a preliminary/final plat conditionally subject to rezoning of property at 980 Buck Dobbs Road. The motion also waived the required drainage study and hydrology study. The motion also required the following changes be present on the final plat:

- 1. Back Yard from 80 to 50 feet
- 2. Front Yard from 80 to 50 feet
- 3. Show Water and Septic
- 4. Signature Block for Mayor and Town Secretary

The motion was seconded by Councilmember Hamilton. The motion carried 5-0

7. Discussion and possible action authorizing the mayor to execute a contract with the Parker County Election Administrator for conducting the May General Election

Councilmember Joseph made a motion to authorize the mayor to execute a contract with the Parker County Election Administrator for conducting the May General Election. Mayor Pro-Tem seconded the motion. The motion carried 5-0.
