

**ORDINANCE NO. 2005-3**

**AN ORDINANCE OF THE TOWN OF ANNETTA NORTH,  
TEXAS RELATING TO OFF PREMISES SIGNS, WITHIN  
THE TOWN OF ANNETTA NORTH; PROVIDING PENALTIES  
FOR VIOLATION; PROVIDING A REPEALER CLAUSE; PROVIDING  
A SEVERABILITY CLAUSE; PROVIDING A ENGROSSMENT AND  
ENROLLMENT CLAUSE; PROVIDING FOR PUBLICATION; AND  
PROVIDING AN EFFECTIVE DATE.**

**WHEREAS, the Board of Alderman seeks to prohibit off-premises signs.**

**NOW, THEREFORE BE IT ORDAINED BY THE BORAD OF ALDERMEN OF  
THE TOWN OF ANNETTA NORTH, TEXAS, THAT:**

**SECTION 1: PROHIBITION**

**Off-premises signs as defined in Section 216.002 of the Local Government Code are prohibited in the Town of Annetta North town limits and it's Extra Territorial Jurisdiction (ETJ) as allowed in Section 226.902 of the Local Government Code.**

**SECTION 2: REPEALER CLAUSE**

**All ordinances or parts of ordinances not consistent or conflicting wit the provisions of this ordinance are hereby repealed; provided that such repeal shall be only to the extent of such inconsistency and in all other respects this ordinance shall be cumulative of other ordinances regulating and governing the subject matter covered in this ordinance. Any cause of action accruing prior to the passage of this ordinance shall continue as if this ordinance was not passed or any other ordinance had not been repealed.**

**SECTION 3: SEVERABILITY CLAUSE**

**That it is hereby declared that the sections, articles, subsections, paragraphs, sentences, clauses, and phrases of this ordinance are severable and if any phrase, clause, sentence, paragraph, subsection, article, or section of this ordinance shall be declared void, ineffective, or unconstitutional by a valid judgment or final decree of a court of competent jurisdiction, such void ness ,ineffectiveness, or unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs, subsections, articles, or sections of this ordinance since the same would have been enacted by the Board of Alderman without the incorporation herein of any such void, ineffective, or unconstitutional phrase, clause, sentence, paragraph, subsection, article, or section.**

**SECTION 4: PENALTY CLAUSE**

Any person, firm association of person, company, corporation, or their agents, servants, or employees violating or failing to comply wit any of the provisions of this Article shall be fined upon conviction not less than one dollar(\$1.00) nor more than five hundred dollars (\$500.00), and each day any violation of noncompliance continues shall constitute a separate and distinct offense; and each sale or solicitation is a separate and distinct offense

**SECTION 5: ENROLLMENT AND ENDORSMENT CLAUSE**

The City Secretary of the City is hereby directed to engross and enroll this ordinance by copying the caption, penalty clause (if any), publication clause and effective date clause in the minutes of the Board of Alderman and filing the ordinance in the ordinance records of the Town.

**SECTION 6: PUBLICATION CLAUSE**

The City Secretary is hereby directed to post or publish in the official newspaper of the Town, the caption, penalty clause (if any), publication clause and effective date clause of this ordinance in one issue of the official newspaper of the Town, provided that the official newspaper is a weekly paper, as authorized by Section 52.011 of the Texas Local Government Code.

**SECTION 7: EFFECTIVE DATE**

This ordinance shall be effective after final passage and publication as required by law.
